Georgie read through the cultural protocols of the new Terms of Reference:

This committee commits to culturally safe and respectful practices that centre the voices of Aboriginal and / or Torres Strait Islander Peoples.

Speaking Order: Aboriginal and / or Torres Strait Islander members speak first on each agenda item. Non-First Nations members may contribute after, with First Nations members invited to speak last before the item is closed.

Private Discussions: At the direction of the First Nations Co-Chair, culturally sensitive topics may be discussed privately by First Nations members. Non-Indigenous members may be asked to leave the room (or digital space) during these discussions.

Cultural Knowledge: Cultural knowledge or stories shared by Aboriginal and /or Torres Strait Islander members remain their intellectual property and must not be shared or reproduced without their consent.

### Suggested changes:

Page 1: add that the Committee meets on the lands of the Wurundjeri Woi-wurrung people and that the Committee provides Council with guidance as well as advice and information.

Page 2: change that a failure to vote is not negative and add in that right to abstain from voting.

Page 3: add the role of the co-chair and length of tenure. Replace intellectual property with Indigenous Cultural and Intellectual Property.

Discussion was also held on whether gender balance needs to be added to the Terms of Reference.

Discussion on reciprocity – the Terms of Reference is a statement of what this Committee will do, request to discuss a statement of Council's commitment to the Committee and First Nations community. This may already be in the Marrageil Strategy, suggest further discussion required.

Discussion on committees member payment.
